Certificate of registration and registration tags shall be valid only during the CALENDAR year IN which they are issued, AND DURING THE FIRST THIRTY-ONE DAYS OF THE FOLLOWING CALENDAR YEAR-Sec. 955.09.

A Penalty shall be assessed if a Dog License is not secured on or before January 31, or within 30 days after the dog becomes 3 months of age, or is brought from outside the state, R.C. Sec. 955.01, 05.

Application for registration for period of one year, three years or application for permanent registration must be filed with the county auditor before January 31, accompanied by a registration fee for each dog over three months old, owned, kept or harbored by the applicant, or such additional fee as is fixed by county commissioners under Section 955.01, 955.14

If such application for registration is not filed and said fee paid on or before the thirty-first (31st) day of January of each year, the County Auditor shall assess a penalty in an amount equal to the registration fee upon such owner, keeper or harborer, which must be paid with the registration fee. Section 955.01.

Every person who purchases a dog from outside the State of Ohio after January 31st and before July 1st, must, make application for registration from January 31st and pay full year's fee; if purchased after July 1, fee is one-half the full fee. Section 955.06.

Every person who owns a dog which becomes three months of age after January 31st and before July 1st, must, within 30 days, make application for registration from January 31st and pay full year's fee; if dog becomes three months of age after July 1st, fee is one-half full year's fee. If such application is not filed within 30 days and fee paid, the auditor shall assess a penalty in an amount equal to the registration fee upon the owner or harborer, which must be paid with the registration. Sections 955.05, 955.06.

Section 955.21. No owners, keeper, or harborer of a dog more than three months of age, nor owner of a dog kennel, shall fail to file the application for registration required by section 955.01 of the Revised Code, nor shall he fail to pay the legal fee therefor.

Section 955.24. No person shall obstruct or interfere with anyone lawfully engaged in capturing an unregistered dog or making an examination of a dog wearing a tag.

Section 955.25. No person shall own, keep, or harbor a dog wearing fictitious, altered, or invalid registration tag or a registration tag not issued by the county

Penalties: (A) Whoever violates sections or divisions of 955.11, 955.21, 955.22, 955.23, 955.24, or 955.25 of the Revised Code is guilty of a misdemeanor. See Section 955.99 R.C.

In case of loss of Registration Tag, law provides a duplicate may be secured at the auditor's office for Five Dollars. Section 955.08.
